## Dear Colleagues,

In 2023, we celebrate the twenty fifth anniversary of signing the Aarhus Convention on Access to Information, Public Participation in Decision-making and Access to Justice in Environmental Matters. Undoubtedly, it is an act playing a fundamental role in enhancing the rights of the members of the public in relation to the common good, i.e. the environment. Therefore, it is necessary to examine the way in which the Convention has impacted the contemporary legal system, taking into account the ongoing discussion about substantive and procedural environmental rights of individuals.

Public participation, embodied in environmental rights (Rio Declaration – principle 10), displays one of the essential aspects of the principle of sustainable development, and, consequently, environmental law. During the past quarter century, important advancements of this legal concept have been made. Thus, with its significance constantly growing, public participation requires anew attention from environmental law scholarship, which should result in the research embracing international, EU and national law perspective. For this reason, we would like to dedicate this year's edition of the seminar, integrating Polish, Czech and Slovak environmental law theoreticians and practitioners, to assessing the current developments in public participation in environmental matters in supranational or domestic legal context. And, we hereby sincerely invite you to present your findings in that regard during the conference, organized by the Department of Environmental Law and PEL of the NCU Faculty of Law and Administration, which will be held on the 1st and 2nd of September 2023.
